**WINGER'S USA, INC. ANNOUNCES NEW MASTER DEVELOPMENT AGREEMENT
FOR THE STATE OF OREGON**

Salt Lake City—July 19, 2006—Winger's USA, Inc., the owner of one of the nation's hottest restaurant franchises, Winger's Grill and Bar, announced today the signing of a new franchisee master-development agreement for the state of Oregon. The new franchisee, WingNutz, LLC, has plans to open multiple new Winger's Grill & Bar restaurants throughout Oregon.

Winger's USA, Inc. already has one franchised location in the state in Ontario, Oregon. WingNutz, LLC will be opening its first Winger's Grill & Bar in Klamath Falls in November 2006, and plans on opening locations in other Oregon cities, including Medford, Bend, Eugene, and Corvallis, among others.

"We discovered – and fell in love with Winger's – at the Ontario store," said Ray Schaeffer, owner of WingNutz, LLC. "After eating there, we just couldn't get enough and so decided to explore opening our own restaurants. We've been involved in the management of quick serve restaurants for over 25 years in the McDonald's and Taco Bell system, and decided now was the time to open our own restaurants."

Winger's USA currently has 36 locations system-wide throughout the western United States and on two U.S. military bases in Germany. "We are thrilled to have Ray and his wife Karen as part of the Winger's family," Eric Slaymaker, president of Winger's USA said.

The first restaurant under the new agreement will open in late November in Klamath Falls. Housed in a 4500-square-foot building, the new restaurant will feature a traditional dining room and a separate full-service bar with big-screen TVs surrounding the room and high-end sound system. Schaeffer projects that the restaurant, when open, will employ around 75 people.

"We are extremely excited about Winger's significant growth in the Northwest," said Slaymaker. "In addition to Oregon, we anticipate announcing another major development agreement in the Northwest within the next few weeks."

Winger's Grill & Bar offers a full-range menu, including entrees, sandwiches, salads, burgers, desserts, full-service bar, and of course, Winger's world-famous wings and sticky fingers.
